Why All Hazard?

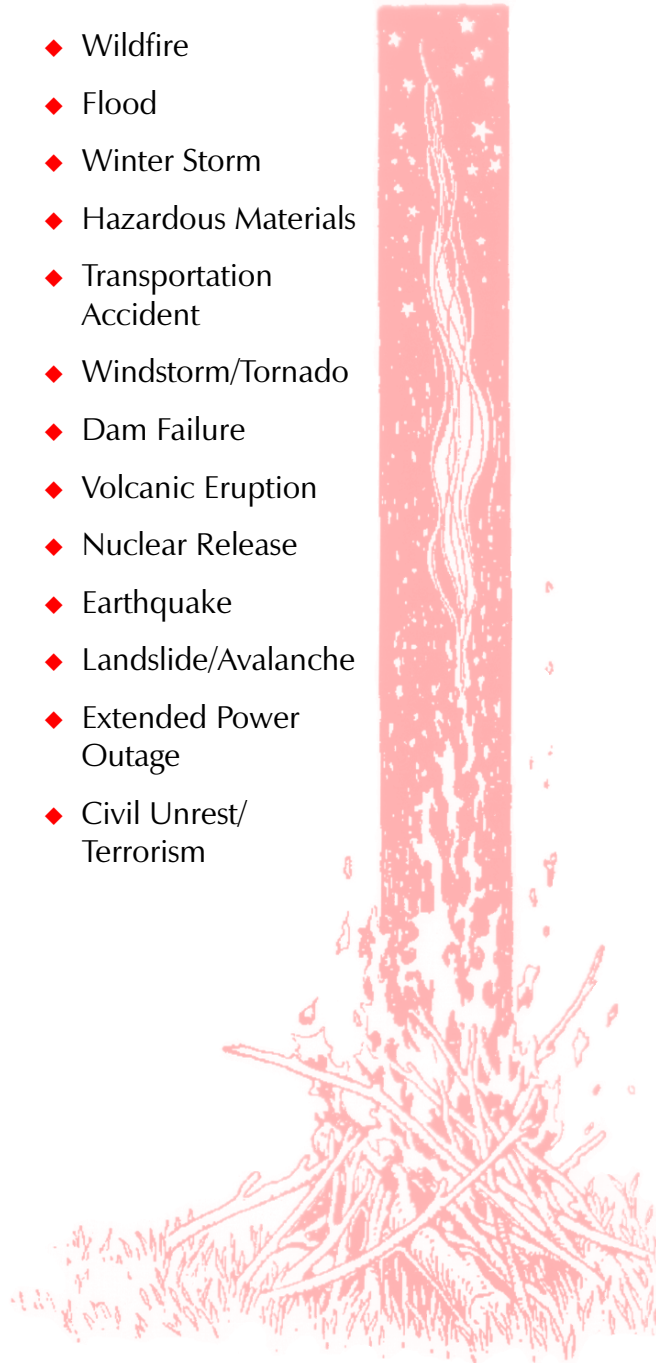

How the LEPC Began

The idea that the more informed the community is, the better prepared they will be to cope with potential hazardous materials problems led to the passage of the SARA Title III Community Right-To-Know-Act.

Under this federal law, each state was required to set up a State Emergency Response Commission (SERC) composed of persons with technical expertise in the emergency response field. They established emergency planning districts and oversaw the formation of Local Emergency Planning Committees (LEPCs).

By an act of the Idaho legislature, the name of the State Emergency Response Commission was changed to "Idaho Bureau of Hazardous Materials" (BHM), effective July 1, 1997.

Kootenai County expanded its LEPC to include all hazards in order to provide more comprehensive and useful information to the residents.

Mission Statement

The mission of the Kootenai County Local Emergency Planning Committee is to promote public safety during any natural or human caused incident.

Goals

To ensure public safety, the Kootenai County Local Emergency Planning Committee will:

- Foster public awareness of any hazard; encourage public involvement in emergency planning by publicizing committee activities; and welcome community input.
- Assist with the updates of the Kootenai County Emergency Operations Plan utilized by all local entities.
- Help local responders as requested with emergency and hazard planning.
- Answer any inquiry according to Community Right-To-Know regulations.
- Provide information, training and/or workshops for SARA Title III compliance within the county.
- Assist industry in complying with Federal and State regulations through information and planning.
